




Fig. 1.5 Picture of 3D Printing

1.5 3D printing

1.10 Computer Ports




Fig. 1.10 Computer Ports

1.10.1 USB port

USB (Universal Serial Bus) is a plug and play interface that allows a computer to communicate with peripheral and other devices. Today, it has replaced PS/2 connectors, game ports, serial and parallel ports, etc. Examples of peripherals that are connected via USB include computer keyboards and mice, video cameras, printers, portable media players, mobile (portable) digital telephones, disk drives, and network adapters.



1.9.2 Type-C port

It is the latest design of the USB port that comes with 24 pins. It can handle a current of 3A. It is also used in devices for fast charging. One of the distinguishing features of this port is that it has no up or down orientation, which means you don't need to flip the male connecter over to plug it in the USB port.




1.9.3 HDMI port



1.9.4 SATA port

SATA stands for Serial Advanced Technology Attachment. It is also known as Serial ATA or SATA. It enables storage devices, such as hard drives and optical drives, to communicate with the motherboard using a high-speed serial cable over two pairs of conductors. We can plug our hard drives in and out of the ports without switching off your computer which makes it a very efficient and durable connector to connect your external hard drives to the motherboard.




1.9.5 Express port

PCI stands for "Peripheral Component Interconnect". It is also known as PCIe. It is an interface standard for connecting high-speed components with your computer system. Every desktop PC has a number of PCIe slots. You can use PCIe to add GPUs (video cards, graphics cards), Wi-Fi cards or SSD cards in your computer.




Fig. 1.15 PCle ports

1.10 Periphe Devices

Peripheral device are also known as Peripheral, computer peripheral or input/output device. Peripherals are commonly divided into three kinds: input devices, output devices, and storage devices.

An **input device** is any hardware device that sends data to a computer, allowing you to interact with and control it.

An **output device** is a piece of computer hardware that receives data from a computer and then translates it into audio, visual, textual, or hard copy such as a printed document.

Let us study some of computer peripheral here:




Fig. 1.16 Computer Peripheral

1.10.1 Mouse

A mouse is a small input device which is used to control the movement of the cursor on the computer screen. It also allows users to move and select folders, text, files, and icons on a computer. Mouse is put on a hard-flat surface to use. When the users move the mouse, a pointer called cursor moves in the same direction on the display screen.

Almost every mouse has three buttons, left, right and scroll on it. These buttons are used for manipulating any objects and text as well. A mouse uses a laser or LED light to control the movement on the screen.

Uses of Mouse

A mouse is capable of performing various functions on a computer, Some of them are as follows: **Move the mouse pointer:** The main function of a mouse is to move the mouse cursor on the screen in the desired direction.

Select: A mouse provides the option to select the text, file, or folder and many files at once.

Open a program: You can open a folder, icon, or other objects using mouse. To open a file, folder, or an icon you are required to move the cursor over it then double click on the object that you want to open or execute.

Drag-and-drop: When you select something, it can also be moved from one place to another using the drag-and-drop method. In this method, first, you need to highlight the file or an object that you want to move. Then, move this file while pressing the mouse button and drop it on the desired location.

Hovering: When you move the mouse pointer on any object, hover changes the color of links, and by clicking on that link, you can go on the destination page.

Scroll Up & Down: If you are working on a large document, you need to scroll up or down a page. Scroll button of the mouse helps to up and down your document page.

Combination Activities: A mouse can be used in many combination activities like, Ctrl + Mouse click can be used for the hyperlink in new windows.

1.10.2 Keyboard

Keyboard is the most common and very popular input device. It helps to input data into the computer. The layout of the keyboard is like that of traditional typewriter, although there are some additional keys provided for additional functions.

Keyboards are of two sizes 84 keys or 101/102 keys, but now keyboards with 104 keys or 108 keys are also available.




Fig. 1.18 Keyboard

Components of Keyboard

Computer keyboards exist in a variety of styles and configurations; however the fundamental parts of all keyboards are the same. A standard computer keyboard is composed of the following components:

• Typing keys • Control Keys • Function keys. • Navigation keys • Numeric Keys

Typing keys

These keys include letter, number, punctuation, and symbol keys found on a traditional keyboard.

Control keys

These keys are used alone or in combination with other keys to perform certain actions. The most frequently used control keys are Ctrl, Alt, the Windows logo key and Esc.

Function keys


The function keys are used to perform specific tasks. They are labeled as F1, F2, F3, and so on, up to F12. The functionality of these keys varies from program to program.

Navigation keys

These keys are used for moving around in documents or webpages and editing text. They include the arrow keys, Home, End, Page Up, Page Down, Delete, and Insert.

Numeric keypad

The numeric keypad is handy for entering numbers i.e 0-9 quickly. The keys are grouped together in a block like a conventional calculator or adding machine.



1.10.3 Printers

A printer is an output device that prints on paper. Printers print text documents, images, or a combination of both. The two most common types of printers are inkjet and laser printers. Laser printers are a typical choice for businesses as well as individuals.

Types of Printers

There are several types of printers available today. Some of them are discussed below:

Inkjet Printers



Inkjet printers recreate a digital image by spraying ink on paper. These printers are mostly used as personal printers.

Laser Printers

Laser printers are used to create high-quality prints by passing a laser beam at a high speed over a negatively charged drum to create an image. Color laser printers are more often found in offices.


3D Printers

3D printers are a relatively new printer technology. 3D printing creates a physical object from a digital file. It works by adding layer upon layer of material until the print job is complete and the object is whole.

LED Printers

LED printers are similar to laser printers but use a light-emitting diode array in the print head instead of a laser.



1.10.4 Scanners

Scanner is an input device, which works like a photocopy machine. It is used when some information is available on paper and it is to be transferred in the computer for further manipulation.

Scanner captures images from the paper and converts them into a digital form that can be stored in computer. These images can be edited before they are printed.

Do you Know?

The first scanner was the MS-200, created in 1984 by the company Microtek

Properties of a Scanner

Resolution

One of the essential features of scanner is the resolution that it is capable of capturing. It is measured in dots per inch. More dots per inch mean high quality of scanning.

Color depth

The color depth is an important concept that refers to the number of bits needed for the representation of the color of each pixel. The higher the color depth, the more colors the scanner can capture.

Recognition

To scan a document, optical character recognition is essential. Computer must convert the file to a text document to identify alphanumeric characters. A scanner provides this facility.

1.10.5 Webcams >

A webcam is a video camera attached to a computer to record or stream to the computer or computer network. They are primarily used for live-streaming or social media. Many laptops have a webcam built in to their screen, but external webcams are also available. Webcam can be used for following purposes:

- Still Images
- Video Recodring
- Video Conferencing

1.10.6 Graphic Card

A graphics card is an expansion card which generates output images to a display device, such as a computer monitor. A graphics card provides high-quality visual display by processing and executing graphical data using advanced graphical techniques, features and functions. A graphics card is also known as a graphics adapter, graphics controller, graphics accelerator card or graphics board.

A graphics card is primarily designed to remove the graphical processing tasks from the processor or RAM. It includes a dedicated graphical processing unit (GPU) and a dedicated RAM that helps it to process graphical data quickly.

- Composing
- Editing
- saving
- printing






2.1.1 Word Processing Software

A word processor is a program that allows us to enter, format, save and print text. Text are words and numbers. Microsoft Word (MS Word) is a popular word-processing program used mainly for creating documents, such as brochures, letters, learning activities, quizzes, tests, and students' homework assignments.

2.1.2 Open a new Word Document


When creating new document in Word, you will often want to start with a new blank document. We have to follow the given steps to open new document in word.

- Open Word. Or, if Word is already open, select File > New.
- 2. In the Search for online templates box, enter a search word like letter, resume, or invoice. Or, select a category under the search box like Business, Personal, or Education.
- 3. Click a template to see a preview
- 4. Select Create.

2.1.4 Adding and Modifying the Text (underline, bold, italicize, font style, font size, font color) to a Document in the Word Processor (MS Word)

Microsoft Word is a word processors software which offers many features which are not found in a traditional text editor or a plain-text file. Some of the most common features of Word includes changing the format (e.g., center), editing the font type, size, and color, inserting pictures, and much more.

Formatting that you apply to text is referred to as character formatting. In the Word document, you can apply character formatting. An individual character formatting includes font, font size, bold, italic, underline, strikethrough, subscript, superscript, font color, and highlight color. Font face can be used to change the shape of the text. This in other words mean that you can alter the handwriting. Font size can change the size of the font and text color can help changing the color of the text. To format any text in the Word document, we first need to select the text. Then we can format the text by using the tabs from the Home tab.




There are 3 types of Font styles on the home tab:

- 1. Bold: this makes the text appear thick and darker.
- 2. Italics: this makes the text slant towards one side.
- Underline: this makes the text underlined with when selected.


2.1.5 Save and Open Files in the Word Processor (MS Word).

 To save, we go to the File tab and press save option or click save button on the quick access toolbar.









2.1.8 Cut, Copy, and Paste Text/Image into a Document

To Cut or Copy

- Select the text or image you want to cut or copy.
- 2. Press the keyboard shortcut;
 - Cut: Ctrl + X
 - Copy: Ctrl + C

Your text or image should now be cut or copied.

To Paste





2.1.10 Create and modify numbered and bulleted lists.

The difference between numbered list and a bulleted list in Microsoft word is that numbered list has the corresponding number associated with it or the current number of sentence that you are writing, whereas a bulleted list does not contain any numbers but only have plain bullets.


Bulleted and numbered lists help to simplify steps or items to readers. We often use bulleted lists to highlight important pieces of our lessons. Manuals often include numbered lists to assist readers with step-by-step instruction.

A bullet is usually a black circle, but it can be any other symbol used to highlight items in a list. Use bullets to list items that do not have to be in any particular order.

Numbers—or letters—are used when information must be in a certain order. You can use the default bullets and numbering settings by clicking the appropriate button on the Formatting toolbar.






2.1.12 Insert and Format a Table.






2.2.2 Adding Various Objects on the Slides (image, text, video, audio, etc.)



While timing your presentation, use the Recording toolbar to advance through the presentation.

- 1. Select Next (arrow pointing to the right) to go to the next slide when the desired timing has been reached.
- 1. Select Pause to start and stop the timing.
- 2. Select Repeat to restart recording the time for the selected slide.
- 3. When you're finished and have set the time for the last slide, close the Recording toolbar.
- 4. Select Yes to keep the recorded slide timings.

How to Edit Timings on a Slide

If you need to increase or decrease the time for your slideshow, change how long slides appear during the slideshow.

To change the timing for a slide:

3.1 Computational Thinking

Computational Thinking (CT) involves a set of problemsolving skills and techniques we use to solve a problem. Computational thinking allows us to take a complex problem, understand what the problem is and develop possible solutions for this problem. We can then present these solutions in a way that a computer, a human, or both, can understand.

Cornerstones of Computational Thinking

There are many techniques that are used for problem solving using Computational thinking, some of the key steps to




Fig. 3.1 Venn Diagram of Computational Thinking

computational thinking techniques are:

- **Decomposition:** Breaking a task or problem into steps or parts.
- **Pattern Recognition:** Finding similarities between comparable and problems.
- **Generalization and Abstraction:** Discover the principles that cause these patterns.
- Algorithm Design: Develop the instructions to solve similar problems and repeat the process.

Decomposition

Decomposition is breaking down complex problems into smaller, more manageable parts. If you can break down a big problem into smaller problems, you can solve them easily. Decomposition is an important life skill.

Example:

We want to host a holiday dinner, Decomposition of the task will be:

- Select the menu
- Enlist support from others in the kitchen
- Task people with what to bring
- Determine the process by which to cook the different elements
- Set the time for the event.

Pattern recognition

Pattern recognition is looking for patterns in the problem and determining if there could be any of the problems or solutions we have faced in the past can be applied here. It may also involve recognizing shapes, sounds or images.

Example:

Pattern Recognition is used to identify similarities between decomposed problems. If


we are developing a game, we can recognize similar objects, patterns, and actions. Finding these allows us to apply the same, or slightly modified, approach which makes our solution more efficient.

Patterns are the laws of nature and life that present themselves in all disciplines of life.





Generalization and Abstraction

Abstraction helps us learn to identify the details that are relevant to solving the problem and ignoring the details that are not relevant to the problem we are solving while generalization allows us to create generic idea of what the problem is and how to solve it. Once we have recognized patterns, we need to put it in its simplest terms so that it can be used whenever we need to use it.



Algorithm Design

An algorithm is a set of instructions for solving a problem or accomplishing a task. In simple words we can say that an algorithm is a sequence of instructions or steps that can be followed by humans and computers to complete a specific task. It is a systematic procedure that produces the answer to a question or the solution of a problem in a finite number of steps.

Characteristics of an Algorithm

Clear and Unambiguous: Each step an algorithm should be clear in all aspects and must lead to only one meaning.

Well-Defined Inputs. Inputs of an algorithm should be well-defined.

Well-Defined Outputs: The algorithm must clearly define what output will be and it should be well-defined as well.

Finite-ness: The algorithm should terminate after a finite time.

Feasible: The algorithm must be simple, generic, and practical, so that it can be executed with the available resources.

Language Independent: The Algorithm must be programming language-independent.

Types of Algorithms

There are several types of algorithms. Some important algorithms are:

Brute Force Algorithm: It is the simplest approach to solve a problem. Brute Force Algorithm goes through all possible solutions until required solution is found.

Recursive Algorithm: In this algorithm, a problem is broken into several sub-parts and called the




Fig. 3.1 Characteristics of an algorithm

Sorting Algorithm: The algorithms which help in arranging a group of data in a particular manner are called sorting algorithms.

Divide and Conquer Algorithm: This algorithm breaks a problem into sub-problems, solves a single sub-problem and merges the solutions together to get the final solution.

Randomized Algorithm: In the randomized algorithm we use a random number so it gives immediate benefit. The random number helps in deciding the expected outcome.

Sequence Structure

In sequence structure steps of an alogorithm / program are executed in the same order as they are written.

Selection Structure

In conditional structure, a statement or set of statements are executed only if condition is true otherwise else part of program is executed.

Example

we can apply if then else condition is finding whether a member is even or odd.

Lepitaton Structure

In problem solving, a loop is a sequence of instructions that is executed again and again until a certain condition is true. If the condition becomes false, the statements outside the branches the

loop are executed.

Types of Loops

There are two most common types of loops:

- Finite loops
- Infinite loops

Finite Loops

The most common type of loop is finite loop. There type of loops have explicit end and these loops execute their bodies for a fixed number of times. A finite loop stops when the condition is false.

Infinite Loops

An infinite loop, have doe not an explicit end. It runs for an infinite time because its condition remains true for iterations.

Example: Repeat forever feature is used for infinite loops in scratch in which object/sprite will repeat its action forever.

Examples of Computational Thinking in Real Life

Computational thinking can be observed in the way people make decisions, do basic arithmetic, and solve problems. The following examples demonstrate how computational thinking is being used to solve real-world problems:

- Using an algorithm to find the best route between your school and your home based on traffic and other factors like construction or road blocks.
- Following a recipe to bake a cake is an example of an algorithm.
- Planning a budget involves pattern recognition and decomposition when you determine your spending habits in each category

Essentials of writing an Algorithm

In order to write an algorithm, the following things are needed as a pre-requisite:

- The **problem** that is to be solved by this algorithm i.e. clear problem definition.
- The limitations of the problem must be considered while solving the problem.
- The **input** to be taken to solve the problem.
- The output to be expected when the problem is solved.
- The **process/solution** to this problem, is within the given limitations/ constraints.

Then we write the algorithm with the help of the above parameters such that it solves the problem.

Example 1. Solve the problem to add three numbers and print the sum.

Step 1: Fulfilling the pre-requisites

As discussed above, in order to write an algorithm, its pre-requisites must be fulfilled.

- **1. The problem that is to be solved by this algorithm**: Add 3 numbers and print their sum.
- 2. The constraints/ limitations of the problem that must be considered while solving the problem: The numbers must contain only digits and no other characters.
- 3. The input to be taken to solve the problem: The three numbers to be added.
- **4. The output to be expected when the problem is solved:** The sum of the three numbers taken as the input i.e. a single integer value.
- 5. The solution to this problem, in the given constraints: The solution consists of adding 3

numbers. It can be done with the help of '+' operator, or bit-wise, or any other method.

Step 2: Designing the algorithm

Now let's design the algorithm with the help of the above pre-requisites:

Algorithm to add 3 numbers and print their sum:

- 1. START
- 2. Declare 3 integer variables num1, num2 and num3.
- 3. Take the three numbers, to be added, as inputs in variables num1, num2, and num3 respectively.
- 4. Declare an integer variable sum to store the resultant sum of the 3 numbers,
- 5. Add the 3 numbers and store the result in the variable sum.
- 6. Print the value of the variable sum
- 7. END

Example 2: Solve the problem print whether a number is even or odd.

Step 1: Fulfilling the pre-requisites

As discussed above, in order to write an algorithm, its pre-requisites must be fulfilled.

- 1. The problem that is to be solved by this algorithm: print whether a number is even or odd.
- 2. The constraints/ limitations of the problem that must be considered while solving the problem: The number must contain only digits and no other characters.
- 3. The input to be taken to solve the problem: A number to be checked whether it is even or odd.
- **4. The output to be expected when the problem is solved:** Evaluate and print value whether even or odd.
- **5. The solution to this problem, in the given constraints:** The solution consists taking remainder of the given number, checking whether the remainder is zero or not. It can be done with the help of 'rem' operator by dividing it with 2 or any other method.

Step 2: Designing the algorithm

Now let's design the algorithm with the help of the above pre-requisites:

Algorithm to find whether given number is even or odd

- 1. START
- 2. Declare an integer variable num1.
- 3. Take the number, to be checked, as inputs in variables num1.
- 4. Declare an integer variable remainder to store the resultant remainder by 2 of the number.
- 5. Remainder = num1 % 2 (% operator is used to get remainder).
- 6. Check IF remainder = 0, then print "number is even', Otherwise print "number is Odd'
- 7. END

Flowchart

A flow chart is a pictorial or symbolic representation of an algorithm. Each step in the flowchart is represented by a symbol which contains a short description of that step. Arrows are used to link different processes in flowchart and they also show the flow of the flowchart. Flowcharts are used in analyzing, designing, documenting or managing a process or program.

Commonly Used Symbols in Flowcharts

Symbol	Name	Description
	Terminal / Terminator	Oval represents start or stop point of a flowchart
	Action / Process.	Rectangle represents process in flowchart
^ ↓	Arrow	Arrow represents direction of flow from one step or decision to another.
	Input/ Output	Parallelogram represent input or output

Rules for Drawing Flowcharts

We should follow the following rules while drawing a flowchart:

- 1. Use conventional flowchart symbols.
- 2. Every flow chart must have the start and End points.
- 3. Each symbol should have one exit point except the decision symbol.
- 4. Flow lines should not cross each other
- 5. The flow lines coming out of the decision symbol should be labeled properly.

Advantages of Flowchart


- Easy to make

- Logics can be easily understood.


Disadvantages of Flowchart

- Difficult to understand for people who don't know flowchart symbols








Example 3: Algorithm to find whether a number is even or odd.

Efficiency of a Solution

There can be more than one solution for one problem and one solution can be more efficient than others. Efficiency of a solution is measured by following parameters:

- No of steps executed by the solution to solve the problem.
- Memory consumed by the solution.

So we can say that efficiency of a solution is always measured in terms of no. of steps taken by the solution. The solution which solves a problem in less no. of steps is considered more efficient than that which takes more steps for solution because memory is not an issue for computer systems now.

Let us see the following example:

Write an algorithm to find largest number from three numbers

Solution1:

- Start.
- 2. Take three unique numbers in A, B, C.
- 3. Set A = largest
- 4. Check if B is greater than largest, set B = largest
- Check if C is greater than largest, set C is largest,
- 6. Print largest
- 7. Stop.

Solution 2:

- Star
- 2. Input three unique numbers A,B and C
- 3. Check If A is greater than B, then go to step 6
- 4. Check If B is greater than C, then print B is largest and go to step 8
- 5. Print C is largest and go to step 8
- 6. Check If A greater than C, then print A is largest and go to step 8
- 7. Print C is largest
- 8. End

Analysis

We can see that solution1 and solution2 are solving the same problem. Solution 1 is solving the problem in seven steps and using four variables A, B, C and largest while Solution2 is solving the same problem in 8 steps and it is using three variables A, B, C. As solution1 solves problem in less No. of steps we can say that solution1 is more efficient than Solution2 although it consumed less memory.

4.1 Computers store information using binary codes

Computers represent everything as numbers. In fact, they can represent everything using the combination of only two numbers that are zero and one. Expressing numbers as a set of zeroes and ones is known as using binary numbers. In computers the numbers are represented by electronic switches. An open switch represents a zero and a closed switch represents a one. With enough switches, virtually anything can be represented as numbers. Another name for these

switches is "bits". These bits are stored in our computers' memories. Eight bits together makes what we call a "byte" of data. You've probably heard of how many megabytes (approximately millions of bytes) or gigabytes (approximately trillions of bytes) your computer can store. Ultimately the amount of memory in your computer

Binary explained

The binary number system was refined in the 17th century by Gottfried Leibniz. In mathematics and in computing systems, a binary digit, or bit, is the smallest unit of data. Each bit has a single value of either 1 or 0, which means it can't take on any other value.

Computers are machines that represent numbers using binary code in the form of digital 1s and 0s inside its central processing unit (CPU) and RAM. These digital numbers are electrical signals that are either on or off inside the CPU or RAM.

4.2 Binary and Decimal number systems

Decimal Number System Definition

The decimal number system is defined as a number system that represents a number with a base of 10 and uses 10 symbols - 0, 1, 2, 3, 4, 5, 6, 7, 8, and 9. It is also known as the Hindu-Arabic number system in which each digit has a position and it is ten times more significant than the previous digit. It also uses a decimal point to represent decimal fractions. For example, if we take 36 as a decimal number, here, 3 is ten times more than 6. Decimal numbers are written as 45_{10} , 118_{10} , and so on. It is the most commonly known number system in which the numbers can be identified easily even if the base is not written. In other words, if the base of a number is not written, it is considered to be a decimal number.

Binary Number System Definition

The binary number system is a number system with base 2 in which numbers are represented only by two digits, 0 and 1. The smallest unit of data in a computer is called a bit, which is the abbreviated form of 'binary digit'. A bit has a single binary value which is either 1 or 0. Binary numbers are written as 110₂, 10₂ and are mostly used in computers for programming or coding since the computer understands the language of only the binary digits, that is, 0 and 1. It should be noted that in a binary number, the bit to the extreme left is called the Most Significant Bit (MSB), and the bit to the extreme right end is known as the Least Significant Bit (LSB). The remaining part shows the magnitude of the number.



In contrast, the decimal numbering system is a base-10 system, where each possible place in a

number can be one of 10 digits (0-9). In a multidigit number, the rightmost digit is in the first place, the digit next to it on the left is in 10th place, the digit further left is in 100th place and so on.

The importance of binary code:

The binary number system is the base of all computing systems and operations. It enables devices to store, access and manipulate all types of information directed to and from the CPU or memory. This makes it possible to develop applications that enable users to do every task we prefer it through computer some of them are following:

- 1. view websites;
- 2. create and update documents
- play games
- view streaming video and other kinds of graphical information;
- 5. access software; and
- 6. perform calculations and data analyses.

The binary schema of digital 1s and 0s offers a simple and elegant way for computers to work. It also offers an efficient way to control logic circuits and to detect an electrical signal's true (1) and false (0) states

4.3 Number System Conversion

Binary to Decimal

To convert binary into decimal we used positional location method, in which each digit has a wait based on its position in the number. This is achieve by multiplying each digit by the base (2) raised to the power depending upon the position of the digit. At end we sum all the values obtained from digits to get the decimal number.

Let us consider following example:

 Convert the binary number 101101₂ to a decimal number.

Step1: List out the power of 2 for all the digits starting from right most position. The first position will be 2⁰ and the next will be 2¹ and so on.


Gottfried Leibniz (1646-1716)

Leibniz, the last universal genius, invented at least two things that are essential for the modern world: calculus, and the binary system.

He invented the binary system around 1679, and published in 1701. This became the basis of virtually all modern computers.

Step2: We will multiplying the value of each digit with its respective binary number starting from

right most position.

Step3: Add all the values regard in the result and express binary number in decimal as shown in the figure.

Decimal to Binary


Step 1: Divide the given decimal number by 2 and note down the remainder.

Step 2: Now, divide the obtained quotient by 2, and note the remainder again.

Step 3: Repeat the above steps until you get 0 as the quotient.

Step 4: Now, write the remainders in such a way that the last remainder is written first, followed by the rest in the reverse order.

Step 5: This can also be understood in another way which states that the Least Significant Bit (LSB) of the binary number is



at the top and the Most Significant Bit (MSB) is at the bottom. This number is the binary value of the given decimal number.


Let us understand this with an example

Example: Convert the decimal number 14₁₀ to binary.

Solution: We will start dividing the given number (14) repeatedly by 2 until we get the quotient as 0. We will note the remainders in order.

There are different methods of converting numbers from decimal to binary. When we convert numbers from decimal to binary, the base of the number changes from 10 to 2. It should

be noted that all decimal numbers have their equivalent binary numbers. The following table shows the decimal to binary chart of the first 20 whole numbers.



Solution: For decimal to binary conversion, let us first divide the given number by 2 and note down the remainders as shown in the following table.

Text, image, and sound representation in binary numbers

Text:

When any key on a keyboard is pressed, it needs to be converted into a binary number so that it can be processed by the computer and the typed character can appear on the screen.



We need a code to represent each character and number in binary.. One code we can use for this is called ASCII. The ASCII code takes each character on the keyboard and assigns it a binary number. ASCII is seven bit code For example:

- the letter 'a' has the binary number 0110 0001 (this is the decimal number 97)
- the letter 'b' has the binary number 0110 0010 (this is the decimal number 98)
- the letter has the binary number 0110 0011 (this is the decimal number 99)

Text characters start at binary number 0 in the ASCII code, but this covers special characters including punctuation, the return key and control characters as well as the number keys, capital letters and lower-case letters.

Do you Know?

ASCII stand for (American Standard Code for Information Interchange)

ASCII code can only represented $2^7 = 128$ characters, which is enough for most words in English but not enough for other languages. ASCII code was extent to $2^8 = 256$ characters but still, it was insufficient to represent other languages. If you want to use accents in European languages or larger alphabets such as Cyrillic (the Russian alphabet) and Chinese Mandarin then more characters are needed. Therefore, another code, called Unicode, was created. This meant that computers could be used by people using different languages as unicode can represent more than


65000 characters.


Images:


Images also need to be converted into binary in order for a computer to process them so that they can be seen on our screen. Digital images are made up of pixels. Each pixel in an image is made up of binary numbers.


If we say that 1 is black (or on) and 0 is white (or off), then a simple black and white picture can be created using binary.

To create the picture, a grid can be set out and the squares colored (1 – black and 0 – white). But before the grid can be created, the size of the grid must be known. This data is called metadata and computers need metadata to









know the size of an image. If the metadata for the image to be created is 10x10, this means the picture will be 10 pixels across and 10 pixels down.

This example shows an image created in this way:

Colors Representation in Binary code

Most commonly, colors are represented in computers using 8-bit numbers. This means that a set of eight zeroes and ones is used to represent a given color component. Every possible combination of eight zeroes and ones gives us 256 possible levels of color we can represent. For example, the decimal integer 0 is represented in 8-bit binary digits as 00000000, while the decimal integer 255 is represented as 11111111.

There are many ways to represent colors with numbers. The most common method in computers is to represent the amount of red, green, and blue primary lights required to mix together to create the desired colors. This is the tradition because most computer displays work by adding together amounts of RGB primaries and the numbers can be used to directly display colors. If 8-bit numbers are used, then we can have values ranging from 0 - 255 for each of the RGB primaries of the color. In that case, black would be represented by (R=0, G=0, B=0) and white by (255,255,255). The red, green, and blue primaries would be represented by (255,0,0), (0,255,0), and (0,0,255) respectively. Similarly, the cyan, magenta, and yellow secondaries would be represented by (0,255,255), (255,0,255), and (255,255,0). Intermediate colors are represented with intermediate numbers. For

example, a middle gray might be (128,128,128) and a pale-yellow color (200,180,120).

As mentioned above, computers represent these numbers as binary numbers instead of decimal integers. Some computer programs represent colors in hexadecimal numbers. Hexadecimal doesn't have ten numerals like decimal (0123456789), but rather has 16 numerals represented by our normal decimal numerals and the first 6 letters of the alphabet (0123456789ABCDEF). The list below shows examples of colors represented with 8-bit decimal, binary, and hexadecimal numbers that all mean exactly the same thing.

Ultimately it is the display or decoding of the numbers that determines the color that you see. (200,180,120) does not turn out to be exactly the same color on all computer displays or printers. This complexity is what makes accurate color reproduction a serious technical and scientific challenge.


Sound:

The sound waves are analogue and in order to store the waves digitally on the computer, we need to convert the waveform into a numerical representation so that the waveform can be stored in binary. To do this, we use an Analogue-to-Digital Convertor (ADC). The ADC works by taking samples of the sound wave at regular intervals and display the diagram.

The quality and size of the file is affected by two factors - sample rate and bit rate. The sample rate refers to the number of samples taken every second and that the greater the frequency of the samples, the better the sound quality.

The bit rate refers to the number of bits used to store each sample and that the more bits that are sampled, the better the accuracy of the file but also the greater the file size.

Alternatively, students could use Audacity (Free audio editor) to explore how sound is stored on a computer. Students could be given an .MP3 file which they open in Audacity and zoom in to see



the value of each sample. Students could then export the sound file using different sample rates and investigate the effect the sample rate has on sound quality.


4.4 Scratch

Scratch is a programming software that makes it easy for us to create interactive games, animations and stories. When scratch opens, it displays a single character by default that is called sprite. We can program sprite to move and interact with the user.

When we open sprite, the following is the displayed interface:

Interface parts	Description
Block categories	This shows the category of the blocks. You can click on the category to see the script blocks it contains.
Block Palettes	It has the list of blocks that can be added to your program when creating it. To add a block, you simply click on it and drag it to the script area.

Stage	This is where the program runs and you can see Sprite in action.

4.4.1 Combination of Programming Constructs

• The concept of combining events & coordinates to allow a user to move a sprite or a sprite moves automatically without user intervention.

What is Movement?

Movement is the most basic function in any game. It's the first thing you do when you start a new game, and it's present in almost every game made in Scratch.

In real life, movement is the only way that we can interact with the world. Just by thinking about it, we move our arms and legs to walk or do anything that we want. Just like in real life, movement is the primary way that we interact with games. By pressing the arrow keys, players tell their characters to move around on screen and complete tasks.



Making characters walk or move around in games lets them interact more with your world.

Because it can be used for almost anything, we should learn how to make sprites move before anything else. This is perfect for Scratchers who are just getting started, and want to make their own creations! In next topic we will explain how to create a sprite and make it controllable.

Making a Sprite Move




Step 1. Select a Sprite.

To start coding in Scratch, we need to create something called a sprite. Every entity in a Scratch project is a sprite. These sprites are characters in your game, which can move around and execute code. By creating scripts for the sprites to execute, we can give them commands and tell them to do anything we want!

Right now, the only sprite in our project is the Scratch Cat, who is in every project by default. If you want to create a new sprite, you can click the Choose a Sprite button, found in the bottom right of the screen. If you simply want to make the cat move, you can skip ahead to step two.

Select a Scratch sprite character using this button at the bottom right of your new project screen.

Clicking this button should bring you to the Sprite Menu, a library of different sprites which you can use in your game. Click on whichever character you like, and Scratch will create them as a new sprite in your game.



Here's what this code says:

"When you press the right arrow key, point towards the right, then move forward 10 steps."

Scratch offers a wide variety of sprites for you to customize your project with.

Step 2. Program your sprite.

Now that we have a sprite, it's time to make it controllable. To make your sprite move, we need to use Scratch blocks in order to create a simple script.


The easiest way to make a sprite move is to use Event Listeners. Check out this code block, which makes sprites move to the right:

Code with an event listener for simple movement to the right.

▶ Tip: To make this process faster, you can right click on your existing code and click Duplicate. This will create a copy of these blocks, which means you don't need to drag and drop as much.


The code consists of a yellow event listener block, followed by two blue motion blocks. The motion blocks actually move the sprite, while the event listener block tells the sprite when to move.

This movement works for any direction. By adding in more blocks like this, we can give our sprite the ability to move in any direction we'd like. Now that we can move to the right, let's create more scripts to make our hedgehog move in all four cardinal directions!



Easily duplicate your code by right clicking and selecting "Duplicate."

Now we have scripts to move in all four directions. Let's take a look at how our sprite moves in each direction. What are the differences between these four blocks of code?



Duplicate and edit your code like above to allow your sprite to move in each direction.

Notice that for each direction, two things are different

- 1. The blocks run when different keys are pressed. For example, our character moves up when the up-arrow key is pressed, and down when the down arrow key is pressed
- 2. The point in direction blocks specify different directions. The numbers in these blocks are degrees, which each represent one of the cardinal directions (right/left/up/down). When these blocks run, they tell our sprite to point towards a specific direction.

The move ten steps block remains the same for all four directions. No matter which direction we move in, we always move at the same speed.

• The concept of setting a condition using mathematical operators on a variable


When we create a computer program, sometimes we need to "remember" a value so that we can use it many times in our code. The best way to do so it to use a variable and assign it a value.

A variable is a named structure that is used by the computer to remember/hold a value.


- When we create a variable, we give it a name and call it a such in the program.
- We assign a value to a variable. This value can be a string, a number, or a letter.
- > We can change the value of the variable as many times as we want in the program.
- > We can create as many variables as we want in our program.

In Scratch, the variable category allows us to create variables, assign value to them, and use them. To create a variable in Scratch, we go to the Variables category and click on make a variable and the following dialogue will appear:

Once we give the variable a name, several blocks will appear to help us use the variable:







Notice when running the above script, the sprite does not mention which two random numbers were chosen.

What if we want it to display the random numbers that were chosen as well as their product? This can be done by using many nested blocks.


X-Y Method:

The easiest way to do this is by first selecting the sprite you want to move. Then, add the following steps to the scrips area:

The sprite will move when the arrow keys are pressed however it will point the same direction.

Step Method

Using these steps, the sprite will turn around while it moves. This is not recommended in a sprite that must turn for other reasons.



Loop Method

Both methods above can also be written as such below (note in this example the X-Y method is used but the steps method will work with this code too if changing direction is desired):

Working with loops in Scratch:

In Control Blocks, there are two types of loops block available. One work for the specific iterations and other loop is forever loop that terminates when a condition is meet. Otherwise, it will behave as a infinite loop.








Unrealistic Expectations

6.1 Business plan:

A business plan is one of the most integral steps in setting your journey to run a successful business, whether as a sole trader, partnership or limited company.

6.1.1 Define business plan and its components:

A business plan is an essential written document that provides a detailed description and a complete overview of the company's future. All businesses must have a business plan. This plan should explain the business strategy and the key goals to get from where you are now to where you want to be in the future. It is also an important tool for an established company that's moving in a new direction. It can also act as a benchmark for the performance of your company.



Key Sections of Business Plan:

· Executive summary:

Development plan of your products:



Market research and strategies:

Elaborate on your market analysis and explain your marketing strategy, including sales forecasts, deadlines and milestones, advertising, public relations to formulate a successful business plan. That's how you combat your competition. If you can't produce a lot of data analysis, you can provide testimonials from existing customers.

• Management and personnel:

Provide bios of your company executives and managers and explain how their expertise will help you meet business goals. Investors need to evaluate risk, and often, a management team with lots



of experience may lower perceived risk.

Financial documents:

This is where you provide the numbers and digits that back up everything you explained in your organizational and marketing sections. Include conservative projections of your profit and loss statements, balance sheet, and your cash flow statements for the next three years.

6.2 Promotion

6.3 Value proposition

A value proposition in marketing is a concise statement of the benefits that a company is delivering to customers who buy its products or services. It serves as a declaration of intent, both inside the company and in the marketplace.

6.4 Quality assurance

The quality assurance is a process that helps a business adheres to its product's quality standards set by the company or its industry. Another way to define the quality assurance is that it is the company's process for improving the quality of its



products.

Many businesses view their quality assurance program as a promise to internal stakeholders and customers that the company will deliver high-quality products that provide a positive user experience.

It is for this reason that quality assurance is a broad process for preventing quality failures. The quality assurance team is involved in all stages of a product's development that are production, testing, packaging, and delivery. In contrast, quality control is a narrower process. Quality control focuses on detecting mistakes, errors, or missed requirements in a product.

6.5 Importance of Project Management and Media Interacy:

It is pertinent to know how an organization perceives project management. Handling projects tends to be an intimidating task hence, It requires a thorough understanding of project scheduling, planning, reporting, tracking, and the importance of project management. - **3. Email marketing:** Email is a great marketing technique to get customers to return to a brand and purchase new products. First, a company must get people to sign up for an email list after they have made a purchase which can be associated with a process of getting customer loyalty and relation building. Then, based on the knowledge they receive from the emails, it is highly likely these customers will return.

- **4. Content Marketing:** Content marketing is creating valuable and relevant content consistently on platforms. A brand can practice content marketing as a tool to achieve better brand awareness by marketing itself as a company that is in touch with and important to the world.

Video marketing:** Video marketing works in coherence with content marketing and is also a popular technique in digital marketing because of the easy access to videos that technology has provided. By creating quality commercials, companies can inflict a long-lasting brand image on its audience heads and get them to think about purchasing.
- **6. Web advertising:** Brands can get themselves more effective marketing and advertising by creating clickable advertisements to put on popular websites.



7. Affiliate advertising: Affiliate advertising is when a brand pays to have a valuable spokesperson with a large audience, usually a blogger or social media influencer, to post about their company so that a company can increase its circulation.

- **9. Creating an App:** The last of the popular digital marketing techniques is creating an app. Creating an app for a brand can give viewers an accessible means of communication and show

6.9 Search Engine Optimization:

SEO stands for "search engine optimization." It means the process of improving your site to increase its visibility when people search for products or services related to your business in Google, Bing, and other search engine. The better visibility your pages have in search results, the more likely you are to gain attention and attract prospective and existing customers to your business.

SEO is a fundamental part of digital marketing because people make trillions of searches every year, often with commercial intent to find information about products and services. Search is often the primary source of digital traffic for brands and complements other marketing channels. Greater visibility and ranking higher in search results than your competition can have a material impact on your bottom line.



6.9.1 Twitter

Twitter emerged from the podcasting venture Odeo, which was founded in 2004 by Evan William, Biz Stone, and Noah Glass. Apple announced in 2005 that it would add podcasts to its digital media application iTunes, and Odeo's leadership felt that the company could not compete with Apple

and a new direction was needed. Odeo's employees were asked about any interesting side projects they had, and engineer Jack Dorsey proposed a short message service (SMS) on which one could send/ share small bloglike updates with friends. Glass proposed the name Twttr. Dorsey sent the first tweet ("just setting up my twttr") on March 21, 2006, and the completed version of Twitter Debuted in July 2006. Seeing a future for the product, in October 2006 Williams, Stone, and Dorsey bought out Odeo and started Obvious Corp. to further develop it.

6.9.2 Snapchat

Spiegel and his co-founder, Bobby Murphy, told Forbes that they met at Stanford University and created Peekaboo, the first version of Snapchat, in the spring of 2011. They wanted to create an app that would send photos that would eventually disappear, and the initial Picaboo app was launched in the iOS App Store in July -- to little fanfare.

This led them to integrate a workaround solution to the screenshot problem: Users could take screenshots on their iPhones, rendering the disappearing effect of Picaboo messages useless. Instead, they built a notification so users would be able to see if someone took a screenshot of their disappearing photo.


In September, Spiegel and Murphy rebranded the app as Snapchat, added the ability to caption photos, and relaunched in the iOS App Store. They focused on the app's technological innovations, more than branding and marketing to make the experience more dynamic than traditional advertising.


6.9.3 Blogs BLOG

Some common and the most renowned examples of successful digital platforms are: Social media platforms like Facebook, Twitter, Instagram, and LinkedIn.


A Digital Business Platform provides a mechanism to
